 - a) The reusable bag sponsors were recognized in the township newsletter.

- d) Arbor Day tree planting on April 26 immediately following road clean up. Deb Noone and Rob Kopf will contact township arborist to assess location, type of tree, number, budget, and potential nursery donors. A suggestion was made to enlist Scout help with the planting.

- e) Native Plant Project Discussed looking at the native plant garden at the front of the township building once daylight is extended.
- f) Deb Noone will check with the township manager for a contact name to determine when there are subdivision or land developments to review.
- g) We're waiting for the Bucks County Penn State Extension to give a list of their presentations and hopefully we can offer one this year to the community.
- h) Long range projects include re-establishing watershed areas of significant township streams and to determine if the township has interest. Alison Kingsley briefly shared the Solebury watershed project. It was conducted over a period of 3.5 years and it involved training watershed stewards, time, costs, commitment. The DEP offers grants for watershed development. The committee will hear more details from Les Isbrandt at the April meeting. He headed up the Aquetong Watershed.
- i) Over the year, this committee may contact other township EACs to share information to hear about their projects.
