

ORDINANCE NO. 2025-02

AN ORDINANCE OF THE TOWNSHIP OF PLUMSTEAD, BUCKS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, ADMINISTRATION AND GOVERNMENT, PART 1, COMPENSATION OF THE BOARD OF SUPERVISORS, TO INCREASE COMPENSATION FOR SUPERVISORS TAKING OFFICE AFTER JANUARY 1, 2026, IN ACCORDANCE WITH ACT 94 OF 2024 AND THE SECOND CLASS TOWNSHIP CODE; AND WHICH PROVIDES FOR AN EFFECTIVE DATE.

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 94 of 2024, which sets forth parameters for the compensation of supervisors of townships of the second class, and

WHEREAS, the act provides that supervisors of townships having a population of 10,000 to 14,999 may be compensated in an amount not to exceed \$5,450 per year, and

WHEREAS, the population of Plumstead Township was 14,021 as of the 2020 Census.

AND NOW, The Board of Supervisors of Plumstead Township, Bucks County enacts and ordains as follows:

Section 1. Compensation.

Chapter 1, Administration and Government is amended at §1-101 to provide for \$5,450 salary to the supervisors of Plumstead Township, consistent with the Second Class Township Code. The revised §1-101 shall read as follows:

§1-101 Compensation of the Board of Supervisors

- A. The compensation of members of the Board of Supervisors who take office after January 1, 2026, shall be Five Thousand Four Hundred and Fifty Dollars (\$5,450) annually in accordance with Section 606 of the Second Class Township Code, 53 P.S. 65606, for townships with a population between 10,000 and 14,999.
- B. Such compensation shall be paid in monthly installments of Four Hundred and Fifty-Four Dollars and 17/100 (\$454.17).

Section 2. Repealer.

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.

Section 3. Severability.

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or part of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of Plumstead Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

Section 4. Effective Date.

This Ordinance shall become effective five (5) days after enactment, although the compensation increase shall become effective for individual seats on the Board of Supervisors only after a new term begins for such seats, on a rolling basis.
