RESOLUTION OF THE BOARD OF SUPERVISORS OF PLUMSTEAD TOWNSHIP AUTHORIZING THE TOWNSHIP TO ENTER INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT WITH BUCKINGHAM TOWNSHIP RELATED TO MAINTENANCE OBLIGATIONS OF LANDISVILLE ROAD AND RIDGEVIEW DRIVE

WHEREAS, Plumstead Township is a Second-Class Township organized and existing pursuant to the laws of the Commonwealth of Pennsylvania;

WHEREAS, Buckingham Township ("Buckingham") and Plumstead Township ("Plumstead") are adjacent municipalities sharing a common borders on Landisville Road and Ridgeview Drive;

WHEREAS, the Second-Class Township Code authorizes Buckingham and Plumstead to layout and maintain roads;

WHEREAS, for a period of time, Buckingham and Plumstead have informally shared maintenance responsibilities for portions of Landisville and Ridgeview Drive;

WHEREAS, the Intergovernmental Cooperation Act, Act No. 177 of 1996, provides that two or more local governments may jointly cooperate with any similar entity located within the Commonwealth of Pennsylvania in the exercise or in the performance of their respective governmental functions, power or responsibilities; and further provides that local governments or other entities so cooperating shall enter into joint agreements as may be deemed appropriate for those purposes; and

WHEREAS, it is the desire of Buckingham and Plumstead to enter into an Intergovernmental Cooperation Agreement to clearly define the maintenance responsibilities of Buckingham and Plumstead in relation to Landisville Road and Ridgeview Drive.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Plumstead Township as follows:

ARTICLE I. <u>INTERGOVERNMENTAL COOPERATION</u>

Plumstead Township is hereby authorized to enter into the Intergovernmental Cooperation Agreement attached hereto as Exhibit "A."

ARTICLE II. <u>SEVERABILITY</u>

In the event any provision, section, sentence, clause or part of this resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provisions, section, sentence, clause or part of this resolution, it being the intent of the Board Supervisors of Plumstead Township that the remainder of the resolution shall remain in full force and effect.

ARTICLE III. REPEALER

All resolutions or parts thereof, insofar as the same are inconsistent herewith, are hereby repealed.

ARTICLE IV. EFFECTIVE DATE

This resolution shall be effective on the date of adoption.
