**A RESOLUTION OF THE PLUMSTEAD TOWNSHIP BOARD OF SUPERVISORS ESTABLISHING REAL ESTATE
TAX RATES FOR THE CALENDAR YEAR 2026**

BE IT RESOLVED AND ENACTED by the Board of Supervisors of Plumstead Township, Bucks County, Pennsylvania, as follows:


1. That taxes are hereby levied on all real property within the Township for the calendar year of 2026 as follows:
 - A. Tax rate for General Fund purposes shall be the sum of 7.02 mils on each dollar of assessed real estate valuation, or the sum or .702 cents on each one hundred dollars of assessed valuation.
 - B. Tax rate for open space and farmland preservation shall be the sum of 0.688 mils on each dollar of assessed real estate valuation, or .0688 cents on each one hundred dollars of assessed valuation.
 - C. Tax rate for debt service shall be the sum of 4.177 mils on each dollar of assessed real estate valuation, or .4177 cents on each one hundred dollars of assessed valuation.
 - D. Tax rate for firehouse and fire equipment purposes shall be the sum of 1.155 mils on each dollar of assessed real estate valuation, or .1555 cents on each one hundred dollars of assessed valuation.
 - E. Tax rate for Township Fire Department paid crew shall be the sum of 3.75 mils on each dollar of assessed real estate valuation, or .375 cents on each one hundred dollars of assessed valuation.
 - F. Tax rate for ambulance equipment and service shall be the sum of 0.4 mils on each dollar of assessed real estate valuation, or .04 cents on each one hundred dollars of assessed valuation.
 - G. Tax rate for Fire and Ambulance capital equipment and purchases shall be the sum of 1.0 mils on each dollar of assessed real estate valuation, or 0.10 cents on each one hundred dollars of assessed valuation.
 - H. Tax rate for Stormwater Management projects shall be the sum of 0.5 mils on each dollar of assessed real estate valuation, or 0.05 cents on each one hundred dollars of assessed valuation.

2. That any resolution or part of a resolution conflicting with this Resolution is hereby repealed insofar as the same affects this Resolution.
