**EMPLOYEE WAGES & BENEFITS**

All regular, full-time employees shall receive increases and adjustments as budgeted following positive performance reviews.

Employee Benefits shall remain in force as approved on January 4, 1998.

All non-uniform full-time employees will contribute 5% towards their health insurance premiums (Eff. 1/2012).

All full-time, participating, non-union employees are released from contributing to PMRS for the year 2026 per the MMO for the pension plan.


