WHEREAS, the Board of Supervisors of Plumstead Township (hereinafter referred to as the "Township") is aware of the "Red Flag Rule" issued by the Federal Reserve System, the Federal Deposit Insurance Corporation, the Federal Trade Commission, the Office of the Controller of the Currency, and the Office of Thrift Supervision; and

WHEREAS, the Township's Board of Supervisors adopted an Identity Theft Prevention Program on December 16, 2008, with Resolution No. 2008-30 and amended this resolution on February 16, 2010, with Resolution 2010-06; and

WHEREAS the Township must renew and, if necessary, amend this program annually.

BE IT RESOLVED, by the Board of Supervisors of the Township, that the Identity Theft Prevention Program adopted by the Township by Resolution No. 2008-30 and amended by Resolution No. 2010-06 is hereby renewed and reaffirmed.

BE IT FURTHER RESOLVED, by the Board of Supervisors of the Township, that the attached Identity Theft Prevention Program Amendment is readopted by the Township as part of the Identity Theft Prevention Program adopted by the Township by Resolution No. 2008-30, amended by Resolution 2010-06, and shall remain in effect.



AMENDED IDENTITY THEFT PREVENTION PROGRAM

No credit cards will be accepted that do not match the name on the water account or the person presenting it.

The Township will require an application for a new account to be completed for all new water customers.

Emergency contact information will be required for all new water accounts.

The Township will require photo I.D. when establishing new accounts.

New account information may be accepted from a title company as they obtain photo identification at the time of settlement.
